2017 was a year of change for our power supplier, CIPCO

2017 was a year of change for Central Iowa Power Cooperative (CIPCO), as we said goodbye to our long-time CEO Dennis Murdock and welcomed Bill Cherrier into the fold as CIPCO's newest executive vice president and CEO. As a board, we're proud of the position CIPCO has within the industry and look forward to continually moving the needle on success for the organization. I'm privileged to serve as your representative on both the local board of directors and the CIPCO board of directors. We look forward to implementing innovative ideas that benefit Guthrie County REC members.

As our cooperative's power supplier, CIPCO has made significant investments in emission- and carbon-free resources of energy, including the development and launch of a 6.4-megawatt, utility-scale solar system, Southwest Solar Farm in Corning. Additionally, the new Heartland Divide Wind project, a 104-megawatt wind farm, will come online in late 2018. Wind, hydroelectricity, nuclear, solar and landfill gas now make up more than 60 percent of CIPCO's total energy portfolio.

An important part of Guthrie County REC's budget is the money each of CIPCO's member systems receives in the form of patronage dividends. These funds represent CIPCO's margins returned to our member-owners, and CIPCO remains committed to returning patronage to its members. In 2017, Guthrie County REC received a total allocation of \$755,910 from CIPCO's patronage distribution.

CIPCO is also committed to providing safe and reliable electricity at the lowest possible long-term

cost to its members. As a not-for-profit electric cooperative, fiscal responsibility is critical to success.



While other G&Ts across the country have implemented rate increases in recent years, the rate at which Guthrie County REC purchases wholesale electricity from CIPCO has remained stable throughout the past decade. In fact, the 2017 system rate was the lowest in 9 years.

At the same time, CIPCO continues to invest in its overall generation and transmission system to ensure our electricity is reliable. CIPCO's 2017 outage rate was only 0.28 hours per member, one of the best reliability achievements on record for CIPCO.

CIPCO and Guthrie County REC are committed to ensuring members are using energy wisely and utilizing available options to reduce excess energy consumption. As a result, CIPCO and its member systems issued more than \$2.7 million in energy-efficiency rebates that saved approximately 28.6 million kilowatt-hours of energy. That includes a 731,070 kilowatt-hour savings for our members.

In my role as a CIPCO director, I'm committed to guiding the organization into the future while maintaining the strong position of the organization as it stands today. I believe board actions have positioned CIPCO well to navigate the changing energy industry over the next several years, allowing both CIPCO and our cooperative to thrive. We remain steadfast in our commitment to deliver safe and reliable electricity to you, our member-owners, and to ensure your needs are met now and in the years to come.

Legislative conference in D.C. was a success

This spring, more than 50 Iowa electric cooperative representatives flew to Washington, D.C., to participate in the 2018 National Rural Electric Cooperative Association (NRECA) Legislative Conference. Together with more than 2,000 fellow cooperative representatives from across the nation, Iowa managers, directors and employees spent 3 days sharing the electric cooperative story in the nation's capital.

Advocates heard speeches from high-ranking policymakers, including USDA Secretary Sonny Perdue and four U.S. senators. They were also able to participate in breakout sessions in which NRECA staff gave policy briefings and tips on how to effectively advocate on Capitol Hill.

In addition to NRECA-sponsored

activities, advocates were able to lobby all six members of the Iowa congressional delegation, House Agriculture Committee staff, DOE Director of Public Affairs Bob Haus, and USDA Undersecretary Bill Northey. Issues discussed included rightsizing pension premiums, Farm Bill reauthorization, protecting Iowa's power supply, and improving rural infrastructure and broadband access.

The group was well received in every meeting, underscoring the continuing success of Iowa electric cooperatives' advocacy efforts. Not only were advocates successful in sharing the cooperative point of view on important federal issues, but they also were effective at maintaining and building relationships with Washington policymakers. ⚡
