JANUARY 4, 2025 ANNUAL MEETING MINUTES

The Annual Meeting of the Members of Guthrie County Rural Electric Cooperative Association was held at the Guthrie County Event Center, Guthrie County Fairgrounds, Guthrie Center, Iowa beginning at 12:36 P.M. on the 4th day of January, 2025.

The meeting was called to order by Steve Bireline, President of the Cooperative, who presided. Julie Kiley, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

Guthrie County District 5 Director Don Schwartz offered an invocation. The Chairman thanked the Litterdale Catering for the meal.

The Chairman stated that the members who had registered at the door had been checked, and that a quorum was present for the transaction of business. A motion was duly made, seconded, and carried to accept the registration in lieu of a roll call. A list of the members who registered in attendance at the meeting is filed at the Cooperative.

The Chairman of the Cooperative offered to have the secretary read a copy of the Notice of the Meeting together with proof of the due mailing thereof. A motion was duly made, seconded and carried to waive the reading. Copies of the Notice and proof of mailing are kept at the Cooperative.

The Chairman asked Attorney Dennis L. Puckett to address the election of Directors. Mr. Puckett stated that the next order of business was the election of three Directors for a term of three years each. Mr. Puckett reported that in accordance with the By-Laws, the Board of Directors had appointed from the members of the Cooperative a Nominating Committee. The members of the Nominating Committee were: Jill Burkhart, Julie Spellman, Beth Griffin, John Masmar, Dennis Van Pelt, Marc VanHouten, Bob Botschelet, Ruth Rowweder and Doug Eckley.

The Report of the Nominating Committee was then presented, nominating the following members for Directors:

The Report of the Nominating Committee was ordered to be identified by the Secretary and annexed to the minutes of the meeting. Attorney Puckett noted that there were no nominations by petition.

The balloting process was explained. In light of the fact there were only 3 candidates for the 3 positions, a motion was made, seconded and carried to direct the Secretary to cast a unanimous ballot for the three nominees.

Attorney Puckett then declared the following individuals had been elected for a term of three years and until their successors shall have been duly elected and qualified:

The Chairman then introduced the Directors.

Vice President Joni Rees introduced special guests, retired employees and retired Directors in attendance. She also introduced all current employees. Rebecca Schwartz was recognized for ten (10) years of service and Lori Hix for thirty (30) years of service.

The Chairman then offered to have the secretary read the minutes of the Annual Meeting of Members held January 6, 2024. Upon motion duly made, seconded and unanimously carried, the reading of the minutes was waived. A motion was then made, seconded and carried to approve the minutes as distributed. The minutes were declared

approved and the Secretary was directed to file them in the records of the Cooperative.

The annual report of the Treasurer was then presented by Julie Kiley. Following presentation, a motion was made, seconded and carried to approve the report. The report was directed to be filed in the records of the Cooperative.

A report of General Manager Cozy Nelsen was presented. She reported on the operations and financial performance of the Cooperative during the past year. She also noted that with negative operating margins in 2023 and 2024, it was time to consider a rate increase. A cost of service study has been done and the Board is continuing its evaluation. This will be the first general rate increase since 2001. Following presentation, the report was directed to be filed in the records of the Cooperative.

Directors Jason Fett and Julie Kiley noted the process of selecting an individual to attend the youth tour. They then introduced Lucas Obert who was the Cooperative’s selected student. Lucas then gave a presentation regarding his trip and the things he learned. He thanked the Cooperative for sponsoring him for the trip. He has been selected as Iowa’s representative to the national meeting in Atlanta, Georgia.

Director Joni Rees introduced Kathleen Deal and Dave McCool, who attended youth tour in 1971 and reflected on their experiences.

The Annual Report of the President was presented by Steve Bireline and the report was directed to be filed in the records of the Cooperative. He also serves on the CIPCO board and included a report on the power supplier. Included in his report was a report on the impact of the tornado that went through Greenfield, Iowa.

Prizes were awarded by lot.

2025 HIGHLIGHTS

SERVICE

- Built 19.9 miles of overhead line to improve the reliability of the power you receive from Guthrie County REC.
- Added 44 new services.
- Finished installing underground line at the third Wambold addition in Stuart which will allow 42 more residential lots.
- Replaced rotten poles that were flagged by our contractor.

EQUIPMENT

- Acquired a new wire trailer from Rice Trailer Co. for line work as earmarked in the 2025 capital budget.
- Acquired a new basket truck from Altec for line work as earmarked in the 2022 capital budget and a new digger truck from Altec for line work as earmarked in the 2023 capital budget. Delivery times for trucks can be up to five years after ordering.

GROWTH

- Finished construction and energized the new Mockingbird substation near Hamlin and continued construction projects at the Perry Industrial Park. These projects add power and reliability to support business expansions in both areas of our service territory.
- Installed new regulators at the Panora and Woodward substations. Regulators help keep the voltage within the desired range for

members who are served by that feeder.

- Serviced line breakers, which are safety devices to help prevent equipment damage, fires, and other hazards when an electrical fault occurs.

COMMUNITY

- Guthrie County REC awarded \$3,000 in college scholarships to three deserving students in the AC/GC, Audubon, and Panorama school districts whose parents are co-op members.
- Marlene Chalfant, Jeremy Gruber, and Brian Marso participated in the Guthrie County ISU Extension and Outreach’s STEM Fest in March. Students were invited to learn more about electricity and had an

opportunity to wear virtual reality headsets to experience a lineman’s view firsthand.

- Loyd Hise participated in Farm Safety Day through Iowa State University Extension and Outreach. Roughly 200 third graders from AC/GC, CR-B, Panorama, and WCV attend the event every May to learn about electrical safety, how to stay safe around grain bins, tractor and ATV safety and proper sun protection.
- Loyd Hise and Jeff Eagle participated in Audubon County Farm Bureau’s Fourth Grade Ag Day in September and talked with students about what linemen do to deliver electricity safely. Students saw a live wire demonstration and learned how linemen use their gear and tools to work safely.
- Jeff Eagle and Carter Drake talked with area high school students during Audubon County Economic Development Career Day in October about what it takes to be a lineman. Teaching opportunities allow our linemen to demonstrate their job, talk about schooling and training, teach electrical safety practices, and educate students about the electric cooperative.
- Sponsored Exira-Elk Horn-Kimballton sophomore Annabelle Baggett on the Electric Cooperative Youth Tour. The weeklong trip to Washington, D.C., in June allows students to learn about electric cooperatives, American history and U.S. government, and explore the sights around the nation’s capital.

LEADERSHIP

- Supported local students in Central Iowa Student Anglers with a \$500 donation.
- Supported the Boys & Girls Clubs of Central SW Iowa with a \$250 donation which supports after school and summer youth programs.

FINANCIAL

- The Guthrie County REC Board of Directors allocated \$983,757.46 of the 2024 margin to GCREC members. The margin is divided into four categories: reserve for contingency losses and expenses, statutory surplus, education reserve, and patronage dividends. The sum of \$983,757.46 was allocated to deferred patronage dividends.
- The Board of Directors approved a pay out of dividends totaling \$692,733.99 to members who received electric service in 2013 (partial), 2015 (partial), and 2024 (partial).
